Voting for this Contest is only open to individuals who are legal U.S. residents of the 50 United States and the District of Columbia, with a valid email address and a valid Twitter or Instagram account, who are at least 21 years of age at the time of voting. - 3. The Final Round will begin on April 4, 2016 at 12:00 a.m. Pacific Time and will end on April 7, 2016 at 11:59 p.m. Pacific Time.
- 4. The Winning Contest City will be announced on April 8, 2016.

Resignation's West Coast Director of Sales' computer will serve as the official time keeping device for this Contest.

<u>**Prize</u>**: The winning Contest City (as determined herein) will host a one-time party and screening of the new movie "Sausage Party," at a location as determined by Resignation within that Contest City (the "<u>Prize</u>").
